In such case the maximum time as specified, viz. <b>Final Registration:</b> 2 Years + 1 Year (Extension) + 1 year (Vice-Chancellor Approval). <b>Final Submission:</b> 5 Years + 1 Year (Extension) + 1 Year (Vice-chancellor Approval). This is the current rule of UGC, 2016 run in State and Central Universities.
