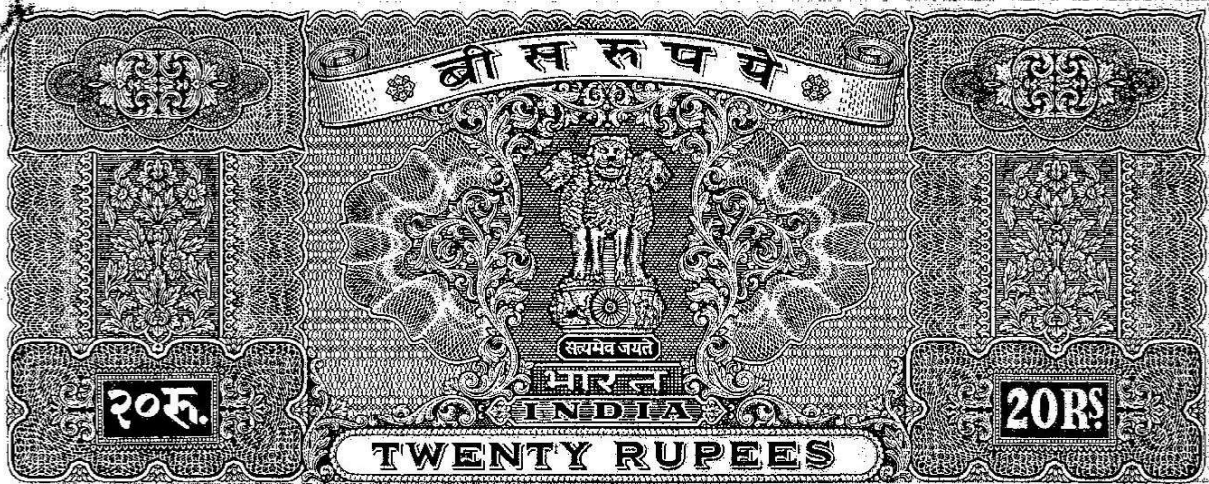

NOW THIS DEED WITNESSETH as follows :

1. The trust shall be named "KRISHNAGURU FOUNDATION"
2. That the present value of the Trust property is taken at Rs. 0.05 Lakhs.
3. That the Registered office of the Trust will be situated at M.L. Nehru Road, Guwahati unless changed by the trustees.
4. That the Trustees shall hold the property movable /immovable and apply the income thereof for the trust set in clause 6 herein under appearing
5. The Trustees are hereby expressly authorised to accept voluntary contributions with or without invitation or moveable or immoveable properties from any person or persons on such terms, conditions as may be deemed proper in their absolute discretion and any such contribution would be accepted both so as to form the corpus of the trust, as well as for the objects of the trust and the provisions contained in this provisions present shall be applicable thereto.

6. AIMS AND OBJECTS OF THE TRUST :

Ever since the creation of this Universe the kindly "LIGHT OF THE ALMIGHTY" has been showing/leading the mankind the path of salvation. When the creatures forget the existence of the ALMIGHTY CREATOR, they are to suffer and face with immense difficulties. In this Tantrik Yuga which has been embraced by the evil influence of KOLI, the mind of the mankind is clouded. This fearful situation has been fuelled terribly by the torture/restlessness of the society. - B. To popularize the idea of DIVINE ONENESS, as enshrined in the holy books and to exchange the spiritual and philosophical principles given in those holy books.
- C. To teach people of the world to show respect to each other, the theory of non-violence, truthfulness, extend helping hand to others and thereby establish a spiritual society eliminating untouchability.
- D. To erect, open, found, construct, establish, take-over, equip, promote, conduct, maintain support assist and make donations etc. to the Than of Nam Prasanga, places

- E. To give and provide with stipends, scholarships, travelling expenses, all allowances or monetary aids to students and scholars in India and outside engaged in the pursuit of any activity in conformity with the trust.
- F. To grant relief in cash and/or kind during natural calamities such as famine, earthquake, flood, fire and other occasions of calamities of the similar nature and to give donation, subscriptions or contributions to the institutions, establishments or persons doing such relief works.
- G. To provide health treatment to ailing people and to help disabled needy persons.
- H. To found, construct, maintain, support, assist or give subscriptions to places of, Prayer or congregational halls or institutions for cultural, social and religious discourses.
- I. To establish, construct, sink, maintain and repair Tube-wells, wells, water-works for supply of drinking water for the use of Public in general.
- J. To establish, open, run and maintain artificial limb fitting centres, service centres for physically handicapped and disabled persons including hearing impaired persons for the benefit of such persons, and also to take up sight conversation activities.
- K. To establish, open, maintain and run vocational training centres, self employment centres for the benefit of suffering humanity in general and particularly youth wing of the society.
- L. To take up the projects of providing irrigation facilities in rural areas of the nation, either independently or jointly with State Govt./Central Govt./Other charitable institutions.
- M. To work for advancement/protection of culture and Literature and to make arrangement for its training.
- N. To develop disciplinary conduct and habit to observe the rule of Law and self restraint amongst general public and teach the duties and responsibility to become a true citizen of the world.
- O. To take up welfare schemes for the benefit of youth community and also to promote and inculcate the dignity of the young generation.
- P. To establish/ maintain huts/bazars for the convenience of the people at Large.

- R. To print, publish, distribute any books, leaflet, journal, mouth piece, news paper etc. in conformity with and for fulfillment/development of the trust, AND to establish printing press etc. for the purpose.
- S. To do any other act in conformity with this trust.
7. MEMBERS OF THE TRUST: Any persons having faith in the aims and objects of the Trust may apply for the membership of the Trust on the terms and conditions decided by the trustees, through the Managing Trustee with his necessary certification/ recommendation. When the Board of Trustees is satisfied with the applicant, then the name of the applicant shall be entered in this Register of members to be kept for the purpose. Each member will have to make a contribution to the Trust which will be decided by the Board of Trustees.
8. ADMINISTRATION OF THE TRUST : The Trust shall be administered by a Board of Trustees consisting of members, number of which shall be decided by His Holiness Shri Shri Arun Goswami or by His Successor. The first trustees mentioned hereinabove shall in consultation with His Holiness Shri Shri Arun Goswami select any more trustees from among the members of the trust whenever necessary. Any vacancy in the Board of Trustees shall be filled by the Trustees in consultation with His Holiness. That if any trustee fails to attend three consecutive meetings of the Board without obtaining leave of the Trust Board, he shall cease to be a trustee. Any trustee may resign by notifying his intent to do so to the Managing Trustee of the Trust and on such resignation being accepted by the Trust Board he will be deemed to have vacated his office. On the death of a Trustee, the remaining Trustees shall in consultation with His Holiness Shri Shri Arun Goswami select a Trustee from among the members of the Trust. All trustees of the Board of Trust shall function during the pleasure of His Holiness Shri Shri Arun Goswami and or His Successor. Normally the terms of office of Board of Trust will be three(3) years subject to the pleasure of His Holiness or His Successor and shall be renominated if necessary.
9. Without prejudice to the generality of the power the Board of Trustee shall exercise the following power and functions subject to such policy as may be laid down by resolution adopted in the meeting of the Board of Trustee. Notwithstanding anything contained in the provision of this deed, the power and functions of all or any of the Trustees and the Board of Trust shall be exercised at the pleasure of His Holiness and or His Successor. Any action/deed whatsoever shall not be deemed to have been done in conformity of this deed of trust unless prior approval of His Holiness and or His Successor. The Successor of His Holiness means His Successor only at Krishnaguru Sevasram at Nasatra.
- i) To manage all the properties and belongings to the trust and to let out any portion of any immovable property at such rent and for such period and on such terms and conditions of rent and /or lease, as the Board may think fit.

- ii) To employ clerks, employees, agents, brokers, contractors, etc. as may be required for managing the affairs of the trust on such terms and conditions as the Board may think fit and also to terminate the services of any such person so employed as and when the Board may decide.
- iii) To pay all charges and municipal or other taxes in respect of any immovable property of the trust and to carry out repairs required to be done for the same and keep the same insured against any risk/damage and to incur all other charges or expenses incidental to the administration and management as the Board may deem fit.
- iv) To open or close accounts with any Bank or Banks in the name of the Trust to be operated by the managing Trustee and deposited therein or withdraw therefrom any money and to operate upon the same and to draw, issue negotiate and discount charges, drafts, pay order, hundies, promissory notes and other bills of exchange, Government securities, debentures and other negotiable instruments. However for large transaction the accounts shall be operated jointly by the Managing Trustee and any one of the Trustees nominated by His Holiness and/or His Successor.
- v) To invest the money of the Trust not immediately required for any purpose of the trust in such manner and upon such terms as the Board may think fit.
- vi) To accept donations, contributions or gifts from any person, trust, institution, authority or Government in any form of moneys, moveable or immoveable property for the trust.
- vii) To sign, seal, execute, deliver and to get registered according to law any deed of sale, conveyance, reconveyance, assurances, lease, mortgage, charges and the documents relating to the properties of the trust.
- viii) To borrow money with or without security and on such terms and conditions as the Board may deem fit.
- ix) To delegate any power as the trustees can lawfully delegate to any person and to execute any such power of attorney as they may think fit for the purpose.
- x) To exercise such other power of authority as may be necessary for the administration and enhancement of the Trust Fund and properties and in the interest thereof.
- xi) To adjust, settle, compromise, compound, refer to arbitration all actions, suits, claims, demands and proceedings regarding to Trust Fund.
- xii) To make, vary, alter or modify schemes, rule and regulations for carrying out the objects of the Trust and for the Management of the affairs thereof and for running any institutions in furtherance of the objects of the Trust and otherwise for giving effect to the Trust.

- xiii) To start, abolish, discontinue and re-start any charity or other charitable institution or institutions for the benefit of general public. ✓
- xiv) To set apart the whole or part of the income and/or corpus of TRUST FUND or part thereof for any of the objects of the TRUST.
- xv) To join, co-operate or amalgamate this Trust with other or others having kindred or allied objects upon such terms and conditions as the TRUSTEES may in their discretion think fit particularly having regard to and in conformity with the object and nature of this Trust.
- xvi) The Board of TRUSTEES may, from time to time frame rules for proper administration of the trust.
- xvii) All matters will be decided by majority.
- xviii) The TRUSTEES shall not be entitled to any remuneration and shall work in an honorary capacity. They shall however be entitled to receive the out of pocket expenses incurred by them in the course of discharging their duties as Trustees.

The TRUSTEES shall be entitled to be indemnified by the Trust properties, against the consequences of all lawful acts done by the TRUSTEES in the course of and discharge of their duties as the Trustees of this Trust and all the costs, charges and expenses thereof.

- 10. MEETINGS OF THE BOARD : A meeting of the Board of Trustee shall be held at least once in every six months for which seven days notice shall be issued by the Managing Trustee. The meeting shall be presided by any of the Trustees. Two third of the trustees shall form the quorum of the meeting.
- 11. ACCOUNTS : Full accounts shall be kept in proper books of accounts and such book of account shall be maintained for each year from 1st April to 31st March.
- 12. All the agreements, contracts, deeds and documents shall be executed on behalf of the Trust by any two of the trustees one of whom must be the Managing Trustee of the Trust but such execution of document must have been approved by the Board of Trustees in a meeting in advance.
- 13. There shall be a common seal for the trust which shall be deposited with the Managing Trustee and the seal will be fixed on documents only in pursuance of resolution of the Board of Trustees.
- 14. AMENDMENT : The Trustees may add, alter or otherwise amend these articles or any portion thereof by a resolution passed by a majority of not less than three fourth of the trustees.
- 15. The aims, objects, purpose and other provisions of this Trust Deed have been framed and laid down in accordance with law so that the trust shall never fail. But if at any time the Trustees find or come to know that any provisions hereinabove is invalid or contrary to law, it shall be their

duty to cancel such provision (s) and treat such provision as cancelled, so that other provisions hereof may not be rendered invalid or otherwise affected.

16. That in any case for whatsoever reasons in the event of dissolution of the trust, the property remaining after satisfaction of the debts or/ and liabilities shall not be distributed amongst the members of the trust, but shall be given or transferred to such other institution or trust having the same object as this trust to be determined by the trustees at or before the time of dissolution or in default by the High Court of Judicature that has or may acquire jurisdiction in the matter.
17. The Trust here created shall be irrevocable.
18. The value of the properties held by the trust on the date of registration is Rs. 0.05 Lakhs.

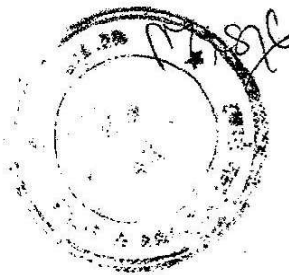

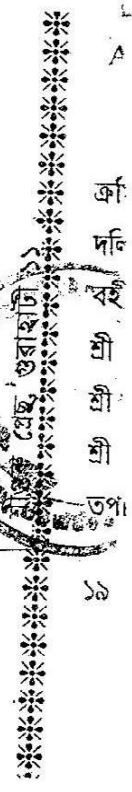

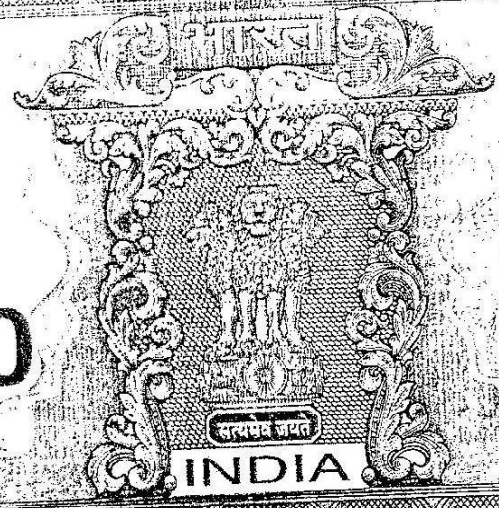

AND WHEREAS, the declarant no.6 Sri Krishna Govinda Mahanta and No.7 Smt. Jayashree Saikia have proposed to include their names as trustee and the same has been accepted by the declarant No.1 to 4 ;
